A DATASET OF INTERNATIONAL LEGAL AND POLICY INSTRUMENTS FOR THE DIGITAL WORLD

This is a new CEPS dataset that provides a comprehensive overview of:

- Policy declarations and instruments at **global or international level**, as put in place by the various UN organisations, the G8/G7, the G20, and the WTO.
- Legal and policy instruments at **regional level** that are relevant to the EU, as put in place by the Council of Europe, OECD, OSCE, and NATO.
- **Free trade agreements** that the EU is party to that have a digital dimension.

This dataset, based on data from 3 January 2025, is a companion and extension to the [Dataset on EU legislation for the digital world](#) that the same authors published as a Bruegel dataset on 6 June 2024.

J. Scott Marcus is an economist, engineer and public policy analyst. He is an Associate Senior Research Fellow in the Global Governance, Regulation, Innovation and Digital Economy (GRID) Unit at the Centre for European Policy Studies (CEPS) and a Professor (part-time) and member of the Scientific Committee of the Centre for a Digital Society, European University Institute (EUI / RSCAS). He also works as an independent consultant dealing with (regulatory) policy regarding electronic communications.

Kamil Sekut is an economist and public policy analyst. He previously worked as a Research Analyst at Bruegel, an economic think tank based in Brussels, where his research focused on innovation, labour economics and public policy. He also has experience in academia and the public sector. Kamil holds a BSc in Economics from the University of Warsaw and an MSc in Economics from KU Leuven.

OUR GOAL

At multiple levels, there has been an absolute explosion of policy documents, declarations, strategies, laws and regulations, and court cases that are relevant to the digital world. Even the best experts struggle to keep up with this torrent of legal and policy instruments being generated at global, international and European levels. The authors are providing successive versions of these datasets because it's important that the research community have tools to help them make sense of this tsunami of legislative measures.

This dataset benefits from prior work. In the 2014-19 legislative term, the European Parliament's Policy Department called for studies to assess the overall results of the legislative term. The [De Strel and Hocepied \(2019\)](#) report on the legal characteristics of the Digital Single Market (DSM) provided a workable taxonomy of EU legislation, which [Marcus et al \(2019\)](#) used as a basis for assessing the economic results of the same EU legislative measures. An [earlier update](#) to this body of work by Kai Zenner further extended that analysis to cover EU legislative measures in the early years of the 2019-24 legislative term. The authors of the current dataset then published three editions of the [Dataset on EU legislation for the digital world](#) as a Bruegel dataset in July 2023, November 2023 and June 2024. The authors gratefully acknowledge all this previous work.

An important common characteristic of all these datasets has been the **classification of policy measures into a taxonomy of thematic areas**. The current international dataset follows the same taxonomy as the June 2024 dataset of EU legislation. We classify the measures depending on whether they primarily relate to (1) research and innovation; (2) industrial policy; (3) connectivity; (4) data and privacy; (5) intellectual property rights (IPR); (6) cybersecurity; (7) law enforcement; (8) trust and safety; (9) e-commerce and consumer protection; (10) competition, (11) media; and (12) finance.

SOURCES, LIMITATIONS AND DISCLAIMERS

The authors have attempted to ensure that the information provided is accurate, but we make no guarantees. Much of the information in our tables – especially information about measures that have already been enacted – is based on standard, publicly available sources. There is, however, a huge amount of material that potentially could have been included – we cannot promise that we captured every instrument that is of potential interest.

NEXT STEPS FOR OUR DATASETS

Our intent from the start was to publish new versions of the EU legislative dataset on an **as-needed basis**. There was no need to publish a new dataset of EU legislation during the second half of 2024 because no new legislative proposals were on the table. Now that the Commission has published its [overall work programme](#) for the new five year legislative mandate, it should be possible to publish an update to the EU legislative dataset soon, taking in particular the 2025 Work Programme, the Simplification Programme and the Competitiveness Compass into account.

This companion dataset of global, international and regional instruments doesn't need to be synchronised with the EU legislative dataset. It's our intent going forward to update it annually.






